



Official Rules for the Stop the Clock Promotion (the “Promotion”)

The Promotion will take place at Point Place Casino Hotel, 450 Rte. 31, Bridgeport, NY 13030 (the “Promotion Site”) on April 3, 2026 from 2:00pm to 6:00pm (the “Promotion Times”), with Hot Seat drawings held at 2:00pm, 3:00pm, 4:00pm, 5:00pm and 6:00pm on April 3, 2026 (the “Drawing Times”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone Resort Casino, including YBR Casino & Sports Book, Point Place and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. To enter the Promotion, eligible participants must demonstrate active slot or table play at the Promotion Site during the Drawing Times and be using their TS Rewards Card to be eligible to be selected to play the Stop the Clock Game for a chance to win prizes during the Promotion. Active slot or table play while using TS Rewards Card at the Drawing Times will constitute one (1) entry per participant per drawing. Use of TS Rewards Card during active slot or table play is required to enter the Promotion.

Prize(s). Two (2) winners will be randomly selected at each Drawing Time from the active player database at the Promotion Site on April 3, 2026 to play the Stop the Clock Game for the chance to win a prize of either a \$50 Free Play, \$100 Free Play, \$150 Free Play, \$250 Free Play or \$500 Free Play. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. Two (2) winners will be selected to play the Stop the Clock Game at each Drawing Time on April 3, 2026 in a random drawing of entries from the Point Place active player database at the Promotion Site for a total of ten (10) winners. Odds of being selected to play the Stop the Clock Game depend on the number of eligible participants actively playing on the Point Place gaming floor while using their TS Rewards Card at each Drawing Time. Limit one (1) winner per Drawing Time. The odds of winning each prize are: \$500 Free Play (1:5); \$250 Free Play (1:5); \$150 Free Play (1:5); \$100 Free Play (1:5) and \$50 Free Play (1:5). By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Selected participant(s) will be notified by an announcement over the overhead speakers at the Promotion Site. The winners must present themselves at TS Guest Services within five (5) minutes of the announcement and then each winner will be allowed to play the Stop the Clock Game to win a prize. Turning Stone, including Point Place, will not be responsible for failure of a participant to hear their name. If no winner presents during the five-minute timeframe, the prize will be forfeited and a redraw will be conducted until the prize is awarded. No compensation will be given for forfeited prizes. Valid photo identification and a valid TS Rewards Card must be presented when claiming all prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won. All prizes won will be issued at the conclusion of participants’ play of the Stop the Clock Game. Any Free Play prizes won will be loaded onto participant’s TS Rewards Card and they will have 48 hours to use the Free Play prize(s). Failure to use any Free Play prizes within the 48 hours will result in the prize being forfeited. No compensation will be given for forfeited prizes. Turning Stone will not be responsible for failure of a participant/winner to utilize any Free Play prize(s) within the allotted 48-hour timeframe.

Stop the Clock Game. Once the winners are present at TS Guest Services, they will be escorted to the Stop the Clock Game and given instructions as to its operation. The winners will be allowed one (1) chance to stop the clock at ten (10) seconds. There are five (5) Free Play prizes and each prize will be designated to a time according to where a winner stops the clock (i.e., if the winner stops the clock earlier than 9.97 or after 10.03 seconds, the winner will receive \$50 Free Play; if the clock stops within .03 seconds of 10 seconds (9.97 or 10.03 seconds), the winner will receive \$100 Free Play; if the clock stops within .02 seconds of 10 seconds (9.98 or 10.02 seconds), the winner will receive \$150 Free Play; if the clock stops within .01 seconds of 10 seconds (9.99 or 10.01), the winner will receive \$250 Free Play; if the clock stops exactly at 10 seconds, the winner will receive \$500 Free Play). Upon completion of the participant’s stopping the clock, the prize values designated are dependent on how the clock stops. The clock and prizes will be reset after each winner plays, so that each winner will have a chance to win the same prizes.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, executives, team members and agents, harmless from all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use their name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

Right to Cancel; Disqualification. Turning Stone reserves the right to modify or cancel the Promotion at any time without notice. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified.
