



Official Rules for Springing for Free Play Hot Seat (The “Promotion”)

The Promotion will take place at Point Place Casino Hotel, 450 Rte. 31, Bridgeport, NY 13030 (the “Promotion Site”) on April 17, 2026 from 2:00pm to 6:00pm (the “Promotion Times”), with Hot Seat drawings held at 2:00pm, 3:00pm, 4:00pm, 5:00pm and 6:00pm on April 17, 2026 (the “Drawing Times”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be a TS Rewards Member and use their TS Rewards Card to participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone Resort Casino, including YBR Casino & Sports Book, Point Place and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. To enter the Promotion, eligible participants must demonstrate active slot or table play during the Promotion Times and be using their TS Rewards Card to be eligible to receive prizes awarded during the Promotion.

Prize(s). There are five (5) Free Play prizes in this Promotion valued at \$250 each. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. Winners of the prizes are randomly selected based on their location on the Point Place gaming floor. Odds of winning a prize depend on how many eligible guests are actively playing on the Point Place gaming floor while using their TS Rewards Card in active slot or table play during the Promotion Times. One (1) winner will be randomly selected by a computer-generated report from the active player database at the Promotion Site, on April 17, 2026 at each Drawing Time, for a total of five (5) winners, to receive prizes. Limit one (1) winner per each Drawing Time. Winners who satisfy all eligibility requirements will receive \$250 in Free Play as their prize. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Upon being selected, in accordance with the computer-generated report, the individual chosen must be seated and actively playing in the location displayed on the drawing report at the time that the prize is awarded. A member of the Promotions Team will notify the winner at the location displayed on the computer-generated drawing report at the time of prize award. All winners will be required to prove eligibility. Winner will be required to provide valid photo identification and a valid TS Rewards Card at time of award to receive any applicable prize. If the individual at the winner’s location is not the same as the person denoted on the drawing report, does not have proper identification or is not actively playing with their TS Rewards Card at the time of award, they will be ineligible for the prize and the prize will be forfeited to another winner. Guests standing near the designated winner and/or “Winner Location” will not be considered eligible to receive prizes. All Free Play prizes won will be automatically added to the participant’s account. Any Free Play prizes won must be used within 48 hours of deposit. Failure to use any Free Play prize within this 48-hour timeframe will result in forfeiture of the prize. Any unclaimed prize will be redrawn for a new winner and/or location. No compensation will be given for forfeited prizes. Winners may be required to complete Form 1099 for prizes won.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, executives, team members and agents, harmless from all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use their name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

Right to Cancel; Disqualification. Turning Stone reserves the right to modify or cancel the Promotion at any time without prior notice. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified.
